### CONTRACT FOR TRANSPORTED SEMEN

#### (A) BREEDING AGREEMENT

This contract is made between FAIRWIND FARM and

The parties to this agreement are subject to the following terms and conditions.

**A Veterinary Certificate indicating a current negative uterine culture showing the mare to be in sound breeding condition and free of infection is a condition for this service. Maiden mares need only a document from a veterinarian stating her maiden status. In all cases, the veterinarian must certify that the mare is current with immunizations for Equine Rhinopneumonitis.**

**(G) Breeding Fees**

The STALLION SERVICE FEE is \$ \_\_\_\_\_ which includes the non-refundable fee of \$500.00. California residents should add sales tax in the amount charged in your area of \_\_\_\_\_ % based on the total Stallion Service Fee. Mares with Elite, Premium or Star quality and Owners with Multiple Breedings in the current breeding season qualify for a 10 percent discount. The Total Adjusted Service Fee is \$ \_\_\_\_\_.

A non-refundable Booking Fee of \$500.00 is due at the signing of this contract. This fee is deductible from the Stallion Service Fee.

A shipping DEPOSIT of \$500.00 to cover container security, collection, and shipping costs is due with this contract. Any unused portion of the shipping deposit will be refunded after the 40 to 50 day pregnancy check. The Stallion Owner will provide the first collection at no charge. All other collections will be charged at the rate of \$250.00 each, plus shipping fees. The Mare Owner agrees to pay for all shipping fees either via airline or overnight Federal Express, and transport to the airport as necessary. (\_\_\_\_) *Initial Here.*

Containers must be returned in a timely manner at mare owner's expense to ensure that we have enough of them to cover all shipments. After receipt of semen, the container must be shipped back to FAIRWIND FARM to arrive within 3 days. (\_\_\_\_) *Initial Here.*

Shipping costs to return empty semen containers are the mare owner's responsibility.

**(H) Collection and Shipment Days**

Semen will be collected only on Monday, Wednesday, and Friday for subsequent next day delivery. All semen orders must be received by 3:00PM PST the day before the requested collection day. Late orders will be filled if it is possible. An additional fee may be necessary if quoted at the time of the request. All orders for semen shipments will be filled as received, subject to the availability of the Stallion. If there is insufficient semen to fill orders on a given day, then FAIRWIND FARM will determine which orders will be honored on that day. We will do our best to accommodate the Mare Owner's request. **(I) Delivery of Viable Semen**

FAIRWIND FARM assumes responsibility to collect and prepare for transport of live and viable semen to the Mare Owner's farm or to the previously approved breeding clinic. The semen must be administered by a licensed veterinarian, or by a breeding technician approved by the Stallion Owner. This approval constitutes a part of this contract and without it the Live Foal Guarantee is null and void. The semen must be administered on the day of delivery in order that the subsequent Live Foal Guarantee applies to the breeding of this mare. FAIRWIND FARM shall be considered to have fulfilled the contractual obligations by delivering live and viable semen.

FAIRWIND FARM is not responsible for lost, delayed or damaged semen, and makes no representation or warranties for any semen furnished except that it is that of the Stallion contracted to be shipped.

It is understood that the veterinarian who is to perform the insemination must contact FAIRWIND FARM by telephone before semen will be shipped. Failure to do so may absolve FAIRWIND FARM of any obligations under this contract. The success of the transported semen program depends upon close cooperation and coordination between FAIRWIND FARM and the veterinarian managing the Mare to be inseminated.

**(J) Pregnancy Confirmation**

The balance of the breeding fee is due when the Mare is declared to be 45 days in foal. A breeding certificate will be issued when the breeding has been paid in full.

The Mare Owner must have the Mare examined by a licensed veterinarian between 40 and 50 days after her last day bred, and FAIRWIND FARM is to be notified of the Mare's pregnancy in order that the Live Foal Guarantee be in force.

**(K) Return Of Service**

If the Mare does not settle during the present breeding season, then the Mare is eligible for Return of Service of the Stallion the following breeding season.

If the Mare is examined in foal, but becomes barren during gestation, the Mare is eligible for Return of Service.

If the Mare produces a live foal that is unable to stand alone and nurse, and subsequently dies, the Mare is eligible for Return of Service, provided that a veterinary certificate of death is issued and sent to FAIRWIND FARM within 10 days.

If the Mare Returns for Service, an amended contract shall be made to reflect the changes in breeding dates.
